During the month of April, Sankalpa team focused basically on activities related to Hon. Margaret Hodge Visit, British Parliamentarian and Ex-Minister. Two management committee meetings (15th April & 26th April) were held in this month to support the Sankalpa's operation. The executive board meeting held on 22nd April formed Constitution Amendment Committee to revise Sankalpa's Constitution. The meeting also decided to organize Special Annual General Meeting on 16th May. Sankalpa Executive Director Ms Chanda Devi Shrestha Rai & Organization Development Advisor Ms Lula Belinfante visited Para Legal Committee and Adolescent Girl Group at Sangachowk VDC of Sindhupalchowk district on 23rd April.

Hon. Margaret Hodge Visit (British Parliamentarian and Ex-Minister)

Sankalpa organized series of programs during the visit of Hon. Margaret Hodge, British Parliamentarian and Ex-Minister as well as gender expert from 31st March -5th April 2013 in coordination with VSO. As per planned, Hon. Margaret Hodge was on a two weeks visit under the parliamentary volunteering scheme of VSO to help women rights advocates to address the issues of domestic violence and the participation of women in politics in Nepal. VSO played vital role for organizing all arrangements for her visit and also supported Sankalpa to organize different programs with Hon. Margaret Hodge. Besides VSO, British Embassy, European Union, DFID also supported to arrange meetings with different Government agencies.

Chair of Inter Party Women's Alliance, Ms. Urmila Pandey welcomed Margaret, VSO team and Sankalpa team for the meeting. Ms. Pandey gave brief introduction on IPWA and its objectives to establish IPWA. IPWA members shared that in the last election

there was 33% representation provided to women on the basis of direct and proportionate electoral system but this time we are not sure to get 33% representation. So, IPWA is continuously lobbying and advocating for 33% representation submitting memorandum to different parties. On this note, Margaret suggested to submit memorandum by developing strategy with plan and proposal to ensure 33% representation in upcoming election collectively which shows women's networking powerful. In the meeting, Sankalpa team also revealed that Sankalpa is planning to support



and capacitate women candidate to get elected in the upcoming election. Hence, Sankalpa requested IPWA to share their need so that we can plan and support women candidate in a solid way. During the meeting, political women from different political parties as well as Margaret shared about their experiences while working for women's rights. The meeting was facilitated by Sankalpa board member Ms. Stella Tamang.
